Anent to the references cited above, the request of M/S Devashree Ispat Pvt. Ltd with its brand name "SHREE TMT" for Empanelment of steel manufacturer in SoR of Government of Telangana 2025, for using its steel in all public works (In all ongoing works and to be taken up in future) taken up in the Telangana State as approved by the Technical committee and Board of Chief Engineers (BOCE'S) is here by accepted with following Conditions.

- The minimum installed production capacity shall be located within Telangana State and shall be 2 Lakh MT per annum.
- II. The relevant documents in respect of usage of Iron ore/sponge iron in production process of reinforcement/structural steel shall be submitted as and when asked by the Engineerin-Charge.
- III. The Firm shall maintain in-house quality control laboratory for testing each lot of steel produced by them as per latest version of BIS codes like IS 1786, IS 432 & IS 2062 etc.
- IV. The Firm shall have valid BIS license for production of steel confirming to relevant BIS standards like IS 1786:2008 (TMT Re-bars), ISO-9001:2008 (Quality Management System), ISO-14001:2004 (Environment Management System), OHSAS 45001:2018 (Health & Safety), IS 2830:1992 (Billets) etc., including valid TMT license from any of firms i.e., Tempcore/ Thermex/ Evcon Turbo / Turbo Quench for production of TMT Re-bars.
- V. The Engineer-in-Charge of the Works shall ensure quality of steel being used in the Projects/Works supplied by the Contracting Agency from the approved steel

manufacturers as per latest version of BIS codes like IS 1786, IS 432 & IS 2062 etc., duly testing the same in NABL (National Accreditation Board for Testing & Calibration Laboratories) certified laboratories.

- VI. The Contracting Agency shall obtain & submit the test reports for each consignment of steel supplied by empanelled Steel manufacturer during execution of work to the concerned Engineer-in-charge.
- VII. If the Steel obtained from the empanelled Steel manufacturer fails to meet the quality standards as per latest version of BIS codes like IS 1786, IS 432 & IS 2062 etc., such Steel manufacturer shall be removed from approved empanelled list of SoR forthwith without assigning any reasons based on the recommendations of concerned ENC/CE.
- VIII. The concerned Departments do not take responsibility or advice for adopting specific brand of steel among approved empanelled Steel Manufacturers. The successful bidders/agencies of Public works are at liberty to procure steel among approved empanelled Steel Manufacturers as per prevailing cost economics, logistics and required quality norms
- IX. The approval is accorded subject to timely renewal of BIS licenses and other licenses & certificates including compliance of guidelines stipulated by the Govt. of Telangana and Ministry of Steel, Government of India from time to time.
- X. The private Steel Companies i.e., other than PSUs shall submit their renewal documents/Certificates by 30th April of every year for continuation of their empanelment of steel manufacturer eligibility in subsequent new SoR w.e.f 1st June onwards, otherwise the accorded empanelment of Steel Manufacturer approval will automatically stands cancelled by the due date, without assigning any reasons.
- XI. The approved Firm shall submit the dealer rates of TMT bars of all diameters to the Chairman, Sub- Committee for evaluating the monthly steel rates.
